# Great Lakes American Water Spaniel Club, Inc. 

Approved and adopted on June 2, 2012 and amended on June 8, 2013, June 26, 2021

## CONSTITUTION

## ARTICLE I

## Name and Objects

SECTION 1. The name of the club shall be Great Lakes American Water Spaniel Club, Inc.
SECTION 2. The objects of the club shall be:
a) to further the advancement of hunting test breeds

b) to do all in its power to protect and advance the interests of hunting tests and to encourage sportsmanlike conduct at such events;
c) to conduct hunting tests and any other event for which the club is eligible under the Rules and Regulations of The American Kennel Club.
d) to disseminate knowledge, conduct classes in and promote the training of purebred dogs;
e) to encourage the training of judges.

SECTION 3. The club shall not be conducted or operated for profit and no part of any prof ts or remainder or residue from dues or donations to the club shall inure to the benefit of any member or individual. these objects.


## Membership

SECTION 1. Eligibility. There shall be five (5) types of membership open to all persons 18 years of age and older who are in good standing with The American Kennel Club and who subscribe to the purposes of this club. Membership types shall be:
Regular - Enjoys all club privileges including the right (a) vote and hold office.
Household - Two (2) adult members residing inefte same household, each eligible to vote and hold office.
Newsletter - Entitled to all club privileges e copt voting and office holding.
Lifetime - Providing voting rights and ch ab benefits to an individual for the remainder of his/her natural life. This form of membership is not transferable.

Honorary - An individual who has made significant contributions to the Sport, Breed or the Club; honorary members pay no dues and are not eligible to vote yitcan maintain regular or household membership if they pay dues.
While membership is tore unrestricted as to residence, the club's primary purpose is to be representative of the breeders and exhibitors in its immediate area. The club's immediate area is defined as Southern Lower Michigan south of a line extending between the city of Ludington and the city of Au Gees, and the metropolitan areas of Toledo, Ohio and Rolling Prairie, Indiana. Only those) members residing within the club's immediate area and holding Regular, Household or Lifetime membership or who live outsigy of the club's immediate area but were voting members on or before June 2, 2012 and maintain that voting member status (80jng forward shall be eligible to vote on matters brought before the membership.

SECTION 2. Dues. Yearly membership dues shall not exceed $\$ 50$ payable on or before the 1st day of June of each year. Lifetime membership dues shall not exceed $\$ 400$.

Dues shall not exceed \$40 (Regular), \$50 (Household), \$30 (Newsletter) or \$400 (Lifetime).
No member may vote whose dues are not paid for the current year. During the month of April the Secretary shall send to each member a statement of dues for the ensuing year.

SECTION 3. Election to Membership. Each applicant for membership shall apply on a form as approved by the board of directors and which shall provide that the applicant agrees to abide by the constitution and bylaws and the rules of The American Kennel Club. The application shall state the name, address, and occupation of the applicant and it shall carry the endorsement of two members in good standing. Accompanying the application, the prospective member shall submit dues payment for the current year.

All applications are to be filed with the Secretary. Once received, the Secretary shall forward to each member of the Board a copy of the application. Each Board member shall then notify the Secretary of his/her approval or denial of the applicant. It shall require an affirmative vote of $2 / 3$ of the board members to elect the applicant to membership.

Applicants for membership who have been rejected by the club may not reapply within six months after such rejection.
SECTION 4. Termination of Membership. Memberships may be terminated:
(a) by resignation. Any member in good standing may resign from the club upon written notice to the Secretar but no member may resign when in debt to the club. Obligations other than dues are considered a debt to the club and must beaid in full prior to resignation.
(b) by lapsing. A membership will be considered as lapsed and automatically terminated if such member s dues remain unpaid 30 days after the first day of June; however, the board may grant an additional 30days) of gracertos such delinquent members in meritorious cases. In no case may a person be entitled to vote at any club meeting whose daes are unpaid as of the date of that meeting.
(c) by expulsion. A membership may be terminated by expulsion as provided in Articlef these bylaws.

## ARTICLE II

## Meetings and Voting

SECTION 1. Club Meetings. Meetings of the club shall be held during the months of March through September or as otherwise called for by the board of directors, within the greater Livingsfongounty, Michigan, area at such hour and place as may be designated by the board of directors. Written notice of each such meeting shall be mailed by the Secretary at least 10 days prior to the date of the meeting. The quorum for such meetings shall be $2 d$ percent of the members in good standing.

SECTION 2. Special Club Meetings. Special club metings may be called by the President, or by majority vote of the members of the board who are present and voting at any reguld $9 y$ special meeting of the board; and shall be called by the Secretary upon receipt of a petition signed by five members of the Clyb who are in good standing. Such special meetings shall be held within the greater Livingston County, Michigan, area at such;place, date, and hour as may be designated by the person or persons authorized herein to call such meetings. Written notice such a meeting shall be mailed by the Secretary at least five days and not more than 15 days prior to the date of the meeting, and said notice shall state the purpose of the meeting, and no other club business may be transacted thereat. The quorum for such a meeting shall be 20 percent of the members in good standing.
SECTION 3. Board Meetings. MCetings of the board of directors shall be held each month within the greater Livingston County, Michigan, area or via telephote conference call or via video conference at such hour and place as may be designated by the board. Written notice of each sucheeting shall be mailed by the Secretary at least five days prior to the date of the meeting. The quorum for such a meeting shallbe a majority of the board.
SECTION 4. SpecidBoard Meetings. Special meetings of the board may be called by the President; and shall be called by the Secretary upon tecelpt of a written request signed by at least three members of the board. Such special meetings shall be held within the greater Kivingston County, Michigan, area at such place, date, and hour as may be designated by the person authorized herein to call suchrqeeting. Written notice of such meeting shall be mailed by the Secretary at least five days and not more than 10 days prior to the date of the meeting. Any such notice shall state the purpose of the meeting and no other business shall be transacted thereat. The quorum for such a meeting shall be a majority of the board.
SLCTION 5. Voting. Each member in good standing whose dues are paid for the current year shall be entitled to one vote at any meeting of the club at which he is present. Proxy voting will not be permitted at any club meeting or election.

## ARTICLE III

## Directors and Officers

SECTION 1. Board of Directors. The board shall be comprised of the officers and one (1) other person, all of whom shall be members in good standing and all of whom shall be elected for two-year terms at the club's annual meeting as provided in Article

IV and shall serve until their successors are elected. General management of the club's affairs shall be entrusted to the board of directors.

SECTION 2. Officers. The club's officers, consisting of the President, Vice President, Secretary and Treasurer, shall serve in their respective capacities both with regard to the club and its meetings and the board and its meetings.
(a) The President shall preside at all meetings of the club and of the board, and shall have the duties and powers normally appurtenant to the office of President in addition to those particularly specified in these bylaws.
(b) The Vice President shall have the duties and exercise the powers of the President in case of the President's death, absence or incapacity.
(c) The Secretary shall keep a record of all meetings of the club and of the board and of all matters of which a record shall be ordered by the club; shall have charge of the correspondence, notify members of meetings, notify new members of their election to membership, notify officers and directors of their election to office, keep a roll of the members of the chbeyth their addresses, which shall be sent to any member in good standing, upon written request, not more than once every gub yer, and carry out such other duties as are prescribed in these bylaws.
(d) The Treasurer shall collect and receive all moneys due or belonging to the club. Moneys shallde deposited in a bank designated by the board, in the name of the club. The books shall at all times be open to inspection by theord and a report shall be given at every meeting of the condition of the club's finances and every item of receipt or paymen not before reported; and at the annual meeting an accounting shall be rendered of all moneys received and expended during therevious fiscal year. The Treasurer shall be bonded in such amount as the board of directors shall determine.
(e) The offices of Secretary and Treasurer may be held by the same person, in which case the board shall be comprised of three (3) persons.

SECTION 3. Vacancies. Any vacancies occurring on the board or amo the offices during the year shall be filled until the next annual election by a majority vote of the members of the board at its firs regular meeting following the creation of such vacancy, or at a special board meeting called for that purpose; except that a walcancy in the office of President shall be filled automatically by the Vice President and the resulting vacancy in the office of Vice President shall be filled by the board.

## ARTICLE IV

The Club Year, Annual Meeting, Elections
SECTION 1. Club Year. The club's fiscal year shall begin on the $1^{\text {st }}$ day of June and end on the last day of May each year. The club's official year shall begin immediately the conclusion of the annual meeting and shall continue through the next annual meeting.

SECTION 2. Annual Meeting. The annual meeting shall be held in the month of June, at which officers and directors for the ensuing election cycle shall be ele ted by secret ballot from among those nominated in accordance with Section 4 of this Article. They shall take office immediately upon the conclusion of the election and each retiring officer shall turn over to the successor in office all properties an yrecords relating to that office within $\mathbf{3 0}$ days after the election.
SECTION 3. Electins. The nominated candidate receiving the greatest number of votes for each office shall be declared elected.

SECTION 4. Nominations. No person may be a candidate in a club election who has not been nominated. Only voting members of the club, who are in good standing, may nominate a member to the Board of Directors. A nomination must receive a second by another fing member and must be accepted by the nominee. No member may nominate himself nor offer a second to that nomination. Nominations may take place at the Annual Meeting or by a letter, electronic or written, sent to the Secretary and received no later than two weeks prior to the annual meeting. Seconds to a written nomination may be made in person at the Annual Meeting or by a written or electronic letter sent to the Secretary.
(a) Nominations cannot be made in any manner other than as provided in this section.
(b) If the proposed candidate is not in attendance at the Annual Meeting in which an election is to be held, the proposer shall present to the Secretary a written statement from the proposed candidate signifying willingness to be a candidate.
(c) No person may be a candidate for more than one position.

## ARTICLE V

## Committees

SECTION 1. The board may each year appoint standing committees to advance the work of the club in such matters as events, trophies, annual prizes, membership and other fields which may well be served by committees. Such committees shall always be subject to the final authority of the board. Special committees may also be appointed by the board to aid it on particular projects.

SECTION 2. Any committee appointment may be terminated by a majority vote of the full membership of the board upon written notice to the appointee; and the board may appoint successors to those persons whose services have been terminated

## ARTICLE VI

## Discipline



SECTION 1. American Kennel Club Suspension. Any member who is suspended from all the privileges, The American Kennel Club automatically shall be suspended from the privileges of this club for a like period.

SECTION 2. Charges. An individual member may prefer charges against another individualmember for alleged misconduct prejudicial to the best interests of the club. Written charges with specifications must be filed in duplicate with the Secretary together with a deposit of $\$ 100$, which shall be forfeited if such charges are not sustained by the board lollowing a hearing. The Secretary shall promptly send a copy of the charges to each member of the board or present them at a board meeting, and the board shall first consider whether the actions alleged in the charges, if proven, might constitutegerduct prejudicial to the best interests of the club. If the board considers that the charges do not allege conduct whichwould be prejudicial to the best interests of the club, it may refuse to entertain jurisdiction. If the board entertains jurisdien of the charges, it shall fix a date for a hearing by the board not less than three weeks nor more than six weeks thereafter. The Secretary shall promptly send one copy of the charges and the specifications to the accused member by registered mail together with a notice of the hearing and an assurance that the defendant may personally appear in his/her own defense and bring witnesses if he/she wishes.

SECTION 3. Board Hearing. The board shall have complete qutherity to decide whether counsel may attend the hearing, but both complainant and defendant shall be treated uniformly in that regard. Should the charges be sustained after hearing all the evidence and testimony presented by complainant and defendant, the board may by a majority vote of those present reprimand or suspend the defendant from all privileges of the club for 0 more than six months from the date of the hearing. And, if it deems that punishment insufficient, it may also recommend to the prembership that the penalty be expulsion. In such case, the suspension shall not restrict the defendant's right to appear befowe his/lier fellow members at the ensuing club meeting which considers the board's recommendation. Immediately after the board finas reached a decision, its finding shall be put in written form and filed with the Secretary. The Secretary, in turn, shall notif egch of the parties of the board's decision and penalty, if any.

SECTION 4. Expulsion. Expulsion of a member from the club may be accomplished only at a meeting of the club following a board hearing and upon the board's recommendation as provided in Section 3 of this Article. Such proceedings may occur at a regular or special meeting of the club, to be held within 60 days but not earlier than 30 days after the date of the board's recommendation of expulsio The defendant shall have the privilege of appearing in his/her own behalf, though no evidence shall be taken at this meeting. The President shall read the charges and the board's finding and recommendation, and shall invite the defendant, if present, tolspeak in his/her own behalf if he/she wishes. The members shall then vote by secret ballot on the proposed expulsion. A $2 / 3 \mathrm{vg}$ g of those present and voting at the meeting shall be necessary for expulsion. If expulsion is not so voted, the board's suspension shall stand.

## ARTICLEXII

Amendments
SECTION 1. Amendments to the constitution and bylaws may be proposed by the board of directors or by written petition addressed to the Secretary signed by 20 percent of the membership in good standing. Amendments proposed by such petition shall be promptly considered by the board of directors and must be submitted to the members with recommendations of the board by the Secretary for a vote within three months of the date when the petition was received by the Secretary.

SECTION 2. The constitution and bylaws may be amended by a $2 / 3$ secret vote of the members present and voting at any regular or special meeting called for the purpose, provided the proposed amendments have been included in the notice of the meeting and mailed to each member at least two weeks prior to the date of the meeting.

## ARTICLE VIII

## Dissolution

SECTION 1. The club may be dissolved at any time by the written consent of not less than $2 / 3$ of the members in good standing. In the event of the dissolution of the club other than for purposes of reorganization whether voluntary or involuntary or by operation of law, none of the property of the club nor any proceeds thereof nor any assets of the club shall be distributed to any members of the club but after payment of the debts of the club its property and assets shall be given to a charitable organization for the benefit of dogs selected by the board of directors.

## ARTICLE IX

## Order of Business

SECTION 1. At meetings of the club, the order of business, so far as the character and nature of the meeting may permit, shall be as follows:

## GLOSSARY

Member in good standing - An individual who is not suspended by The American Kennel Club or their Club and whose dues for the year are already paid.

Reprimand - A written warning to a member after charges have been filed in accordance with the bylaws, and it is determined that the member's conduct was not severe enough to warrant a suspension or a recommendation for expulsion.

Notices - All club notices must be sent either via the US Postal Service or e-mail in accordance with AKC policy.
